

**INSTRUCTIONS: REQUEST FOR MAIL BALLOT**

1. Complete this form and mail, e-mail or deliver to the Chief Election Officer, Castlegar City Hall, 460 Columbia Avenue, Castlegar, BC, V1N 1G7, email: [nbrown@castlegar.ca](mailto:nbrown@castlegar.ca) as soon as possible. *The form must be received by City Election Staff no later than **4:30 p.m. September 23, 2022** in order for you to receive a mail ballot (if you qualify).*
2. If your application is complete and you qualify to vote by mail, the Chief Election Officer will send you a mail ballot package on or around **September 27, 2022.**
3. You are responsible for ensuring that your completed ballot is received by City Election Staff at Castlegar City Hall by **4:00 p.m. on Friday, October 14, 2022** (preferred) **or** if necessary, at the Castlegar & District Recreation Complex on **General Voting Day, Saturday, October 15, 2022**, no later than 8:00 p.m., close for voting.
