A bylaw to exchange a portion of a public highway.

WHEREAS Section 574(1) of the Municipal Act provides that Council may by bylaw dispose of a portion of highway in exchange for land necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS it is deemed expedient and in the public interest to dispose of a portion of a highway in exchange for land necessary for the purpose of improving and widening a highway;

NOW THEREFORE the Council of the City of Castlegar, in open meeting assembled, enacts as follows:

1. This bylaw may be cited as "Highway Exchange Bylaw 725, 1995".
2. That a portion of the highway shown outlined in heavy black line on the explanatory plan attached to and made part of this Bylaw is hereby exchanged for land necessary for the purpose of improving and widening 37th Street.
3. This bylaw shall be advertised in the Castlegar Sun prior to adoption.
4. This bylaw shall come into full force and effect upon final adoption.


