

CITY OF CASTLEGAR

BYLAW 773

A bylaw for the levying of rates for municipal, hospital, and regional district purposes for the year 1996.

---

WHEREAS Section 273 of the Municipal Act requires that Council adopt a bylaw to impose rates on all taxable land and improvements according to their assessed value;

NOW THEREFORE the Council of the City of Castlegar, in open meeting assembled, enacts as follows:

1. This bylaw may be cited as the "1996 Tax Rates Bylaw No. 773".
2. Schedule "A" attached to and forming part of this bylaw is hereby adopted as the following Tax Rates imposed and levied for the year 1996:
  - (a) for all lawful general and debt purposes of the municipality, on the value of land and improvements taxable for general municipal purposes, those rates set out in Column "A" of the Tax Rate Schedule, attached hereto as Schedule "A";
  - (b) for hospital purposes, on the value of land and improvements taxable for regional hospital district purposes, those rates set out in Column "B" of the Tax Rate Schedule, attached hereto as Schedule "A";
  - (c) for purposes of the Regional District of Central Kootenay, on the value of land and improvements taxable for regional hospital district purposes, those rates set out in Column "C" of the Tax Rate Schedule, attached hereto as Schedule "A";
  - (d) for the purpose of the Downtown Revitalization Specified Area on the value of land and improvements assessed for general municipal purposes, rates appearing in Column "D", of the Tax Rate Schedule, attached hereto as Schedule "A"; and
  - (e) for the purpose of the Rick Holdings Shopping Development Specified Area on the value of land and improvements taxable for general municipal purposes, rates appearing in Column "E" of the Tax Rate Schedule, attached hereto as Schedule "A".

3. This bylaw shall come into full force and effect upon final adoption.


READ A FIRST TIME on the 16th day of April, 1996.
