

CITY OF CASTLEGAR

BYLAW 897

A bylaw to close a portion of a public highway.

WHEREAS Section 527(1)(b) of the Municipal Act provides that Council may by bylaw close a highway, or a portion of it, to traffic;

AND WHEREAS it is deemed expedient and in the public interest to close a portion of public highway to traffic;

NOW THEREFORE the Council of the City of Castlegar, in open meeting assembled, enacts as follows:

1. This bylaw may be cited as “Highway Closure Bylaw 897(10th Avenue and 3rd Street)”.
2. That a portion of the public highway lying between:
 - i) Lots 1 - 7, Block 19, District Lot 181, Kootenay District Plan 650 and Lots 8 and 19, Block 19, District Lot 181, Kootenay District Plan 650
 - ii) Lots 8 - 13, Block 19, District Lot 181, Kootenay District Plan 650 and Lots 14 - 19, Block 19, District Lot 181, Kootenay District Plan 650
 - iii) Lot 1, Block 19, District Lot 181, Kootenay District Plan 650 and Lot 7, Block 14, District Lot 181, Kootenay District Plan 650
 - iv) Lots 8 - 13, Block 19, District Lot 181, Kootenay District Plan 650 and Lots 14 - 19, Block 14, District Lot 181, Kootenay District Plan 650
 - v) Lots 5, 6 and 7, Block 14, District Lot 181, Kootenay District Plan 650 and Lot 19, Block 14, District Lot 181, Kootenay District Plan 650
 - vi) Lots 8 - 13, Block 14, District Lot 181, Kootenay District Plan 650 and Lots 14 - 19, Block 14, District Lot 181, Kootenay District Plan 650

all as shown outlined in heavy black in Schedule “A” which is attached to and forms a part of this bylaw, is hereby closed and stopped up to traffic of all kinds.

3. This bylaw shall come into full force and effect upon final adoption.

4. Highway Closure Bylaw 479 is hereby repealed.





HIGHWAY ABANDONMENT

WHEREAS the Council of the City of Castlegar has by Bylaw No. 897, cited as "Highway Closure Bylaw 897 (10th Avenue and 3rd Street)", a copy of which is attached hereto, stopped up and closed to traffic that portion of highway as shown in heavy outline on the plan attached to and made part of said Bylaw No. 897 and more particularly described as follows:

Those portions of District Lot 181, Kootenay District, shown as Closed Lane and Closed Road on Plan NEP 66254

AND WHEREAS the Council has requested the Minister of Municipal Affairs to abandon the aforesaid portion of highway under Section 525 of the *Local Government Act* and to vest title to the land comprising same in the name of the municipality and has demonstrated to the satisfaction of the Minister that special circumstances exist which warrant the making of this Order:

AND WHEREAS the consent of owners of contiguous properties has been obtained and the question of access is not in issue:

I HEREBY order that the portion of highway aforesaid be abandoned and that title to the lands comprising same be vested in fee simple in the name of the City of Castlegar without further instrument of transfer subject nevertheless to the reservations, limitations, provisos and conditions expressed in the original grant thereof from the Crown and subject to the provisions of Section 50 of the *Land Act*.

 - iii) Lot 1, Block 19, District Lot 181, Kootenay District Plan 650 and Lot 7, Block 14, District Lot 181, Kootenay District Plan 650
 - iv) Lots 8 - 13, Block 19, District Lot 181, Kootenay District Plan 650 and Lots 14 - 19, Block 14, District Lot 181, Kootenay District Plan 650
 - v) Lots 5, 6 and 7, Block 14, District Lot 181, Kootenay District Plan 650 and Lot 19, Block 14, District Lot 181, Kootenay District Plan 650
 - vi) Lots 8 - 13, Block 14, District Lot 181, Kootenay District Plan 650 and Lots 14 - 19, Block 14, District Lot 181, Kootenay District Plan 650

all as shown outlined in heavy black in Schedule "A" which is attached to and forms a part of this bylaw, is hereby closed and stopped up to traffic of all kinds.

3. This bylaw shall come into full force and effect upon final adoption.




