#### **ELECTOR REGISTRATION**

If you are not on the list of electors, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

- 18 years of age or older on general voting day for the election
- Canadian citizen
- resident of BC for at least 6 months immediately before the day of registration
- resident of OR registered owner of real property in the City of Castlegar for at least 30 days immediately preceding day of registration, and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election and not otherwise disqualified by law.

To register, resident electors must produce 2 pieces of identification (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**To register, non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner, **written consent** from the other property owners. Consent forms will be available at the voting place, or may be obtained in advance by contacting the Chief Election Officer at (250) 365-8973.
