

2020 Property Tax

Council has delayed property tax penalties of 10% until **October 1, 2020** for those who need more time to pay, providing important and timely relief to those struggling during the COVID-19 pandemic.

Payment Methods

1 Through Financial Institutions

Property taxes can be paid through most financial institutions in person or online.

2 Through your Mortgage Company

The City of Castlegar is not responsible for errors made by mortgage providers. Please ensure that your mortgage provider is aware you are claiming the Home Owner Grant (if applicable).

If your Financial Institution/Mortgage company pays your property taxes, it is your responsibility to claim the Home Owner Grant.

3 In Person at City Hall by Appointment Only:

Until City Hall re-opens, taxes can be paid in-person **by appointment only** by cash, cheque (payable to the City of Castlegar) or Interac. To schedule an appointment, call us at 250.365.7227.

4 By Mail or Dropbox at City Hall:

How to Claim the Home Owner Grant

1 Online:

Claim your Home Owner Grant online at: castlegar.ca/HOG

You will need the **last 8 digits** of your Roll Number (including the decimal and Personal Access Code) to claim your Home Owner Grant online.

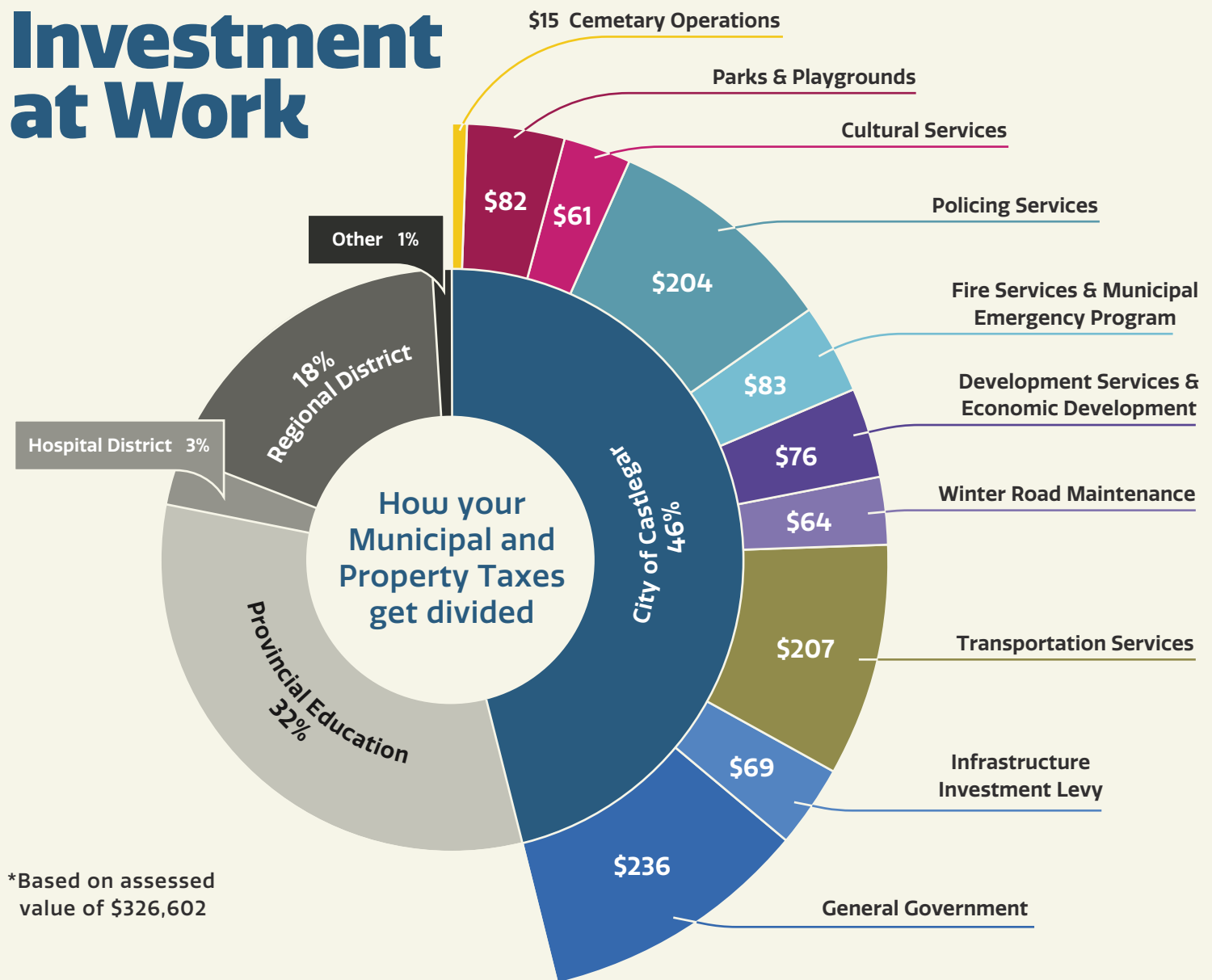
